Privacy Notice

Ilkley Harriers AC (The Club) is committed to protecting your privacy, and takes its responsibilities regarding the security of user information very seriously. For any personal data you provide for the purposes of your membership, The Club is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way.

What personal data we hold on you

You may give us information about you by filling in forms at an event or online, or by corresponding with us by phone, e-mail, WhatsApp or otherwise. This includes information you provide when you register with the Club, or participate in discussions on our social media channels. The information you give us may include your name, date of birth, address, e-mail address, phone number, name of the EA affiliated Clubs with which you are registered and gender (Athletics Data). We may also ask for relevant health information which is classed as special category personal data.

Why we need your personal data

The reason we need your Athletics Data is to be able to administer your membership, and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal

data is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

For training and competition entry

- sharing personal data with club coaches or officials to administer training sessions;
- sharing personal data with club team managers to enter events;
- sharing personal data with facility providers to manage access to the track or check delivery standards; and
- sharing personal data with leagues, county associations and other competition providers for entry in events.

For membership and club management

- processing of membership forms and payments;
- sharing data with committee members to provide information about club activities, membership renewals or invitation to social events;
- publishing of race and competition results

Any special category health data we hold on you is only processed for the purpose of passing health data to coaches and run leaders to allow the safe running of training sessions. We process this data on the lawful basis of consent. Therefore, we will also need your explicit consent to process this data, which we will ask for at the point of collecting it.

On occasion we may collect personal data from non-members (e.g. such as any non-member participant who fills in a health disclaimer or form at a taster event). This information will be stored for 12 weeks after an event and then destroyed securely. Our lawful basis for processing data is consent.

Therefore, we will also need explicit consent from non-members to process this data, which we will ask for at the point of collecting it.

The Club has a presence on the following outward facing social media pages: Facebook, Instagram. The Club has a Facebook group for members only. The Club also has a WhatsApp group. All members are free to join these groups. If you join one of the groups, or comment on any of the posts the Club posts on social media pages, please note that provider of the social media platforms have their own privacy policies and that the Club does not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media pages or within the groups.

Who we share your personal data with

When you become a member of the Club, you will also automatically be registered as a member of England Athletics Limited. We will provide England Athletics Limited with your Athletics Data which they will use to enable access to the MyAthletics portal. England Athletics Limited will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. The Club uses 'Membermojo' to assist with its membership administration. The information you have provided to The Club by means of a membership application form is stored on a password protected, encrypted, UK based web-server database for the purposes of recording membership, writing to your home address with club correspondence, and distributing club emails relating to renewals, forthcoming races, or official club events. We will also use your contact details in an emergency situation. Only selected members of the Ilkley Harriers Committee and club coaches have access to your personal information. We will never divulge your contact details (such as email address, telephone numbers, or home address) to any other party without your prior consent. In other words, even if another member requests your details, we will first contact you to ask for your authorisation before passing on any information.

Transfer of personal data outside of the UK

The Club does not store or transfer your personal data outside of the UK.

Criminal data and automated decision-making

The Club does not collect criminal convictions data. Neither does automated decision-making or profiling take place

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. Whenever you renew your membership, you are asked to review the Athlete data we hold for you. When you cease to be a member any personal data we hold about you will initially be archived, and then securely destroyed after a maximum of one year of inactivity on that member's account.. Your data is not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you may at any time request details of the personal information which we hold about you. If you would like a copy of the information held about you please contact the Membership Secretary. If you think we hold incorrect information please contact the Membership Secretary. As a data subject you are not obliged to share your personal data with the Club. However if you choose not to share your personal data with us we may not be able to register or administer your membership.

Photographs & Running Results

Photographs are often taken of Ilkley Harriers taking part in running events. The photographs are used by The Club on our website, and in club publicity and promotion.

Results – including full names – of Ilkley Harriers who have taken part in races and running events are normally posted on our website. Please be aware that when you participate in any sporting event, your results will be published on the organiser's site and numerous other race results sites. In many cases photographs are posted with runners and individuals are identifiable.
